2. Acceptance of Minutes of previous meeting MOTION: that the minutes of the meeting of Wednesday 2<sup>nd</sup> September be accepted. Proposed: Cr Jackie Fristacky Seconded: Cr Tom Melican The motion was: CARRIED

#### 3. Presentation: Peter Parker – Victorian Transport Action Group

Peter spoke about why we should care about bus services, what's wrong with them and how they can be economically made better.

Peter described 10 bus projects across Melbourne concentrating on direct and frequent buses to major stations, universities and shopping centres, that could be quickly implemented at little or no cost.

He finished noting:

- We can cheaply have buses every 10 minutes in some areas by merging overlapping routes.
- Scope exists to expand SmartBus to key destinations eg shopping centres and universities.
- Can start getting SRL and Airport Rail benefits many years earlier with improved buses to 'prepare the ground'.
- Many local upgrades, such as improved operating hours and frequency, possible without buying new buses. Buses are quick to roll out but may still have a >2 year lead time. With government fully committed on infrastructure and an election in 2022, the time is right for local government to advocate for better buses.
- 4. Presentation: Loretta Lynch TransDev

Loretta spoke about why the benefits of electric buses – and that their contribution to improved air quality is one of the reasons for their strong uptake in European cities.

She also spoke about the current electric bus trial in Melbourne, the NSW government's plans to have 1000's of electric buses, and some of the issues which are being looked at in expanding the potential use of electric buses – including the need to find locations for rapid charging stations along routes.

#### 5. Strategic Transport Advocacy

Greg Day noted the announcement by Minister Carroll that Victoria would be adopting the Metre Matters rule, and that it would be valuable if members re-inforced the appreciation of this decision when speaking with local members.

Greg noted that our cycling ambassador Tom Melican had recently been interviewed on 3AW on the speed limits advocacy and that a key outcome for the State government is to create JOBS JOBS JOBS, so members should emphasise this outcome where appropriate.

#### 6. Treasurer's report

Treasurer Cr Anna Chen spoke to the July Treasurer's report, noting one invoice of \$1,100 (Incl GST) for Greg Day's June/July services which had been considered and approved for payment by the Executive.
