2. Acceptance of Minutes of previous meeting

3. Presentations – Lauren Pearson, Zoe McMaster

MS Lauren Pearson, PhD candidate at Monash University presented the findings of her research into attitudes to cycling within metropolitan Melbourne. Her work involved surveying 4000 participants and sought to build on the much used Portland work. Sufficient responses were received to establish statistically significant data for each LGA.

Her findings include that the "No Way/No How" segment was lower than expected, that there is great potential to build on the "Interested but Concerned" segment, especially in fringe suburbs, and that transport infrastructure projects could be better oriented towards preventing poor health outcomes, and improving transport equity.

Her work gathered data on household type, and income, and correlated the data against their bicycle ownership, use, and riding frequency.

Ms Pearson offered to provide data to MTF members. She also invited feedback/suggestions on questions which might be included in future surveys. Ms Pearson can be emailed on lauren.pearson@monash.edu.

Ms Zoe McMaster presented on the Moreland Streets for Schools pilot at East Brunswick Primary School which was run in March 2021. Following analysis of Moreland's demographic data, and by working on the opportunity to make changes during COVID conditions, the project sought to explore the potential to re-prioritise road space to assist school families remain active, but also achieve social distancing recommendations.

Interest was sought from local schools, and over 1/3 of Moreland's primary schools expressed interest. One school was selected. A 200 m section of the street immediately adjacent to the school was closed for an hour at the end of the school day.

The project was thoroughly planned, to ensure that the school community, and local residents were engaged in the project design. School students were heavily involved in the co-design of the events.

At the end of the project a noticeable increase in active transport had been achieved. Ms McMaster stressed that engagement activities were important to the success, but these could be as simple as providing coloured chalk to encourage the community to claim the road space which was made available for them.

- The State government has recently released its bus plan.

- The aims of the plan are:
 - A bus network that better meets public transport needs and demand.
 - Network reforms and innovation that make the most of Victoria's \$80 billion Big
 Build and provide a pathway to effective and efficient future investments.
 - Cleaner, smarter fleets with more bus types that best suit the passengers who use them and the routes they take
 - Improved information delivery to passengers to let them know about their real-time services and changes to their services due to network disruptions.
 - A better managed, more efficient and fit-for-purpose bus network with services that deliver great value for money.
 - o Improved accessibility and safety.
- The six objectives are:
 - Make the network simpler, faster and more reliable;
 - Introduce a cleaner and smarter fleet;
 - Better performing buses;
 - A better customer service experience;
 - Better governance and system management; and
 - Delivering better value for money.
- The DoT report that bus patronage during the pandemic has remained much higher than all other public transport modes.
- We are working on a bus forum to be held in mid October (after Term 4 has commenced). We are talking with the MAV about partnering on a half day event.
- We are also working with the MAV to get a briefing from the DoT on the bus strategy for councils, this will probably also be a day time event.
