2. Acceptance of Minutes of previous meeting

3. Presentation Rob Hill "Introduction to Metro Trains Operations and Passenger delivery"

Rob Hill, Chief Operating Officer (Interim) of Metro Trains, was the guest speaker at the March meeting.

He provided an overview of the company's role as the rail operator running metropolitan train services 7 days a week on 15 lines over 998 kilometres of track with 226 six-carriage trains.

Rob's presentation touched on a number of topics including:

- Strengthening the diversity of Metro's workforce and offering great career opportunities for everyone;
- Patronage trends, which fell to as low as 10 per cent of pre-pandemic levels, and Metro's work on encouraging passengers to return to the network;
- Challenges presented by trespassers an insight into the high cost and impact on service delivery when people improperly gain access to non-passenger areas.

Diversity and inclusion

Rob provided an interesting insight into the 6,700+ workforce and the progress Metro has made towards being a more diverse and inclusive organisation. In 2022, Metro clocked up an Australian first, recruiting its 500th female driver, a number which has now risen to around 530. This is highest number of female drivers on any rail network in Australia. In 2009, there were just 26 women driving trains on Melbourne's network. Now, women represent 37 per cent of all Metro Trains drivers.

Trespasser impact

Rob also provided an insight into some of the challenges involved in managing a complex rail network, including:

- The large areas of unfenced track which allow access to the rails and rolling stock;
- The high cost and impact on service delivery when people improperly gain access to non-passenger areas.

Taking action to keep our railway, passengers and Metro team members safe include the deployment of drones that capture live footage and identify any trespassers on the rail corridor. Metro is also growing its Network Security and Surveillance team to support trespass management, repeat presenters and people threatening self-harm, protection of rolling stock and protection of infrastructure assets.

Innovation and safety

Rob talked about Metro's innovation program which included the installation of contactless lifts and safety improvements which are being built into the new metro tunnel infrastructure, such as platform screen doors.

5. Strategic Transport Advocacy

5.1 Advocacy

Ms Jane Waldock provided an update on Mr Day's activity on behalf of MTF:

- MTF has invited Minister for Transport Ben Carroll to attend a future monthly meeting, as is the custom of previous years, potentially for June post State budget
- Also looking for meeting with Roads Minister Melissa Horne, waiting on timing of the meeting with Minister Carroll
- Started planning for exec engagement with key cross benchers, Greens Katherine Copsey as their Transport spokesperson, Legalise Cannabis Victoria MLC's and looking for key outer suburban government members as potential transport allies. Suggestions welcome
- Writing to Minister for Transport Ben Carroll about timing of bus review announcements – Greg would appreciate hearing from any council about their expectations / concerns about timing of the reviews

5.2 2023/4 MTF Strategic Action Plan

The Strategic Action Plan was discussed – an amendment was proposed:

- Remove specific examples to ensure actions consider whole of metro Melbourne.
- There was also discussion about some potential activities within the actions which could include:
 - The Bicycle Ambassador following up on previous commitments by the State to achieve 25% active transport by 2030.
 - The Bus Ambassador following up on the State government's objective concerning increasing bus patronage
 - The Tram ambassador to advocate for increased tram services when LXR projects close rail services for extended periods.

MOTION: That the draft 2023-24 Strategic Plan Actions be adopted.

6. Council Information Sharing

Cr Bernadette Thomas from Maribyrnong, Mr Simon Stainsby from Merri-bek, Mr Lawrence Seyers from Nillumbik, and Ms Nellie Montague from Port Phillip provided updates on transport projects and policies in their m municipalities.

Cr Thomas described that Maribyrnong have prepared a submission to Infrastructure Victoria on buses, are currently undertaking road safety audits at six schools, have school focussed work including an Active Path program around schools, and are also working on an Open Street program.

Mr Stainsby reported that Merri-bek are talking to the DoT about the bus reform program – looking to see implementation of actions in the Northern corridor which include Hume, and Darebin. Other activities include:

- o Community engagement re sustainable transport in Fawkner
- o Negotiations with Vic Track and MTM to renew the licence for the Upfield shared path
- Plans to extend the Upfield shared path to the Ring Road
- Advocacy to duplicate sections of the Upfield line north of Gowry
- Following up on the trial of being able to carry bicycles on carriers at the from of buses which was run 3 years ago.

Mr Seyers described Nillumbik's major transport project – to develop a new Integrated Transport Strategy – which aims to include previous active transport strategies, into a single document. This work is being undertaken by consultants PMP.

Ms Montague described Port Phillip's transport projects which include:

- Development of a new car share policy
- A new parking management policy
- The mid program review of Port Phillip's ITS
- Family E-Bike trials (try before you buy)
- Healthy tacks to school
- St Kilda Road bicycle lane
- E scooter trials.
