2. Acceptance of Minutes of previous meeting

3. Presentation Mr Bhavin Mehta and Mr Michael Smith – City of Melton.

Bhavin and Michael presented on the detailed modelling process which the City of Melton has undertaken recently as part of its planning processes. The analysis is used for Melton's advocacy on major roads projects, and is also used in engagement with residents.

The model accounts for all transport modes, and projects volumes into future decades, however, it is difficult to get satisfactory results for active transport modes. The model is used to examine the consequences of potential infrastructure treatments such as road widenings, and new links.

The model is currently being used by Melton to support its advocacy for a high quality bus network to support the growing population of the city.

4. Strategic Transport Advocacy

4.1 2022 Town Hall Series

Greg Day provided an update on the 2022 Town Hall forum process.

- The Melbourne Town Hall date has held on 28 July, with Government and Opposition speakers attending and speaking as part of the panel. Over 100 people attended in person, and over 300 people registered to watch on line.
- Greg noted that this event was well in advance of the election campaign which usually kicks off after Grand Final Day.
- Greg noted that the opposition speaker Mr Matthew Bach had a strong interest in projects in the west.

5. Council Information Sharing

Councillors and officers from Casey and Darebin reported on transport strategies, projects and advocacy in their municipalities. The mayor and officers from Yarra Ranges also presented on transport issues).

- Mr Ted Teo described Casey's program:
 - Safe Around Schools continues to grow with innovative initiatives such as videos to improve road user safety, education and active travel around schools. Currently there are 97 schools in Casey with 18 more planned in the future.
 - Working with the Victorian Planning Authority on three new Precinct Structure Plans (PSPs) in Croskell, Casey Fields South and Devon Meadows.
 - Continued advocacy leading to the state election on:
 - Clyde Rail Link extension of duplicated rail line from Cranbourne to Clyde
 - Clyde Road Corridor

- A complete arterial road network
- o Pedestrian and bike bridge over Princes Freeway at Soldiers Road
- Bus advocacy.
- Casey, like other councils, faces increased pressure to deliver infrastructure due to rising costs and delays such as DoT approvals for design and construction.
- Mr Dave Logan described Darebin's transport projects:
 - The Darebin Transport Strategy is being refreshed (it was last updated in 2015) to reflect emerging modal priorities on major networks.
 - The impact of Covid
 - Electric vehicle policy especially vehicle charging options looking at requirements in new developments.
 - It will also reflect community interest in safety around public transport, especially the "last mile" of the journey. The Strategy will also reflect freight management in the city.
 - The "Your Street/Your Say" engagement project which is covering 1/3rd of Darebin, and will roll through the remaining areas over the next two years.
- Mayor Jim Child described transport projects in Yarra Ranges.
 - The Yarra Ranges 2020-2040 Integrated Transport Strategy
 - The 2022 council advocacy strategy calls for improvements to roads for agribusiness.
 - The Warburton Mountain Bike Destination project is a major project.
 - The condition of the Melba Highway
 - Mr Varmalis noted the importance of the tourism economy to the municipality, and that the parks and trails strategy is a vital part of attracting tourists. These are described in the Ridges and Rivers advocacy objectives.

Council officers discussed the use of the Remix demand responsive software. It was noted that the licences for the software is expensive, and it was proposed that councils might work together to develop a combined licence arrangement resulting in lower costs per council.
