2. MTF executive 2023 Elections

Councillor Marsden stepped down from the Chair in order that the election of the 2023 executive could occur.

Executive Officer Jane Waldock reported that 6 nominations for positions on the Executive had been received as follows:

4. Presentation Nuno Pires and Dr Luisiana Paganelli – Integrated transport planning: learnings from Curitiba and Lisbon

Nuno Pires described the transport changes introduced in Lisbon since 2011 as part of a 20 year plan to reduce transport related emissions in response to climate change. Lisbon saw a reduction in private vehicle use of 3 % over 6 years.

Lisbon's bold strategy includes removal of vehicles from the town centre by banning old vehicles, dramatically reducing on street parking spaces (with fewer cars entering the city, fewer spaces were needed), putting roads on diets to create bike lanes, 30kph speed limits in the majority of streets, and neighbourhoods with restricted access — residents only- and legislation changes that prioritise pedestrians over other road users.

Dr Luisiana Paganelli spoke about how transport oriented design can transform a city, and can also expand with a city, as a Curitiba expanded from 300,000 people to over 2,000,000 over four decades. She described how Curitiba's plans were created in advance of the expansion of the city, and provided the basis for implementation over many years.

Curatiba's plans were based around multiple transport modes, allowing excellent access by all users, it is a trinary system with space for local access, arterial travel, and separate bus throughout the city. It has well integrated and distinct bus services, easily recognised by colour coding, with transport interchanges designed into the network from the start.

5. Strategic Transport Advocacy

5.1 New MTF Strategic Plan

The EO introduced the draft strategy and asked members to send any feedback to her so that a final version can be prepared for adoption at the March general meeting..

6. Council Information Sharing

Bhavin Mehta from Melton, and Damir Agic from Moonee Valley reported on transport strategies, projects and advocacy in their municipalities.

Mr Mehta outlined the continuing work on the Digital Transport Strategy and Active Transport Plan which can be seen at the www.moving.elton.com.au web site.

The strategy aims to develop with roads public transport and active transport options for Melton to reduce traffic congestion and high car dependence.

Moving Melton shows the detailed road, rail, bus and active transport infrastructure projects that would better connect the community, support up to an extra \$19 billion economic output a year and create an additional 120,000 local jobs by 2050.

Mr Damir Agic described the wide range of transport projects currently underway in Moonee Valley including:

- Advocacy on Airport Rail, particularly to include a new station at Keilor East, and integration with other transport modes.
- Pop up bike
- EV Charging stations
- School environs to improve behaviour around schools and encourage 20 minute neighbourhoods
