We want to meet with key transport ministers and opposition spokespeople.

We want to have good examples of local government asks when we have these conversations.

From this feedback we will create our pitches for discussions with parties transport people.

Some of the themes which arose in the groups included:

- Wanting better communication/information on state projects
- The funding of cross council projects for example on arterial roads
- Bus reform, and better links to activity centres.
- Bus services/tram connectivity
- Shared pathways
- Lower speed limits
- Road safety
- Electrifying and duplication rail
- Providing more bus services with higher frequency
- Pedestrian and cyclist safety
- Accessible tram stops
