# 2. Acceptance of Minutes of 3 September 2025 meeting

#### 3. Presentation: Mr Michael Contreras – Go-Ahead

Go Ahead's Global Rail Operations Michael Contreras, Executive Director of Operations for Go Ahead Australia and New Zealand Rail, presented an overview of the company's global operations. Go Ahead, a 30-year-old public transport company, began in the UK and has expanded to operate in multiple countries, including Norway, Sweden, Singapore, and Australia.

Michael highlighted Go Ahead's experience in rail and bus operations, including their recent acquisition of the Stockholm Metro and their involvement in the Elizabeth Line in the UK.

Michael presented an overview of Go Ahead's operations in the UK, including their partnership with Keolis and their role in managing the City of London's rail network. He highlighted the size and scope of the network, which includes 432 trains, 1,300 kilometres of route, and 7,300 employees. Michael also discussed their involvement in major infrastructure projects like the Thameslink program and the East Coast Digital Program, which have improved network capacity and introduced digital signalling.

Michael shared that while the UK has done well in anticipating network demands, projects like Thameslink took 15 years from planning to groundbreaking. He emphasized the importance of pre-empting future city needs, particularly in Melbourne, where population growth is expected to exceed Sydney's.

Michael discussed the Thameslink program in London, highlighting its high-frequency service and capacity. Michael explained that the change management process for such infrastructure investments involves extensive training and collaboration with unions, taking 1-2 years to implement smoothly. He noted that Melbourne's rail network, with its huband-spoke design, is similar in size to the UK's GTR network but presents unique operational challenges.

#### **CBTC and ETCS System Comparisons**

Michael discussed the viability of CBTC (Communications-Based Train Control) and ETCS (European Train Control System), noting that both systems achieve similar outcomes but many networks globally are moving towards ETCS due to its interoperability benefits.

# Monash.

Ms Sandra Worsnop from Monash Council's presented on the Oakleigh protected two way cycleway project between the Scotchman Creek's Trail and the Djerring Trail along Atkinson St.

The project, which began in 2021, is nearing completion with stages 1 and 2 expected to open in December 2025. The project involved removing 40 parking spaces and installing precast concrete curbs, with community support despite initial concerns about road space changes.
